Therefore, no conclusions should be drawn regarding the presence or absence of such additives. The current and valid permit number for the facility issued by a human health or food safety regulatory entity with authority over the facility is stated above, and that the facility meets the human health or food safety sanitization requirements of the regulatory entity as documented by the regulatory entity and evidenced by the valid permit number
